FREQUENTLY ASKED QUESTIONS (FAQS)

FAQs for Members

1. What preventative care services does GEMS cover?

GEMS covers a wide range of preventative care services, including cholesterol, blood pressure, glucose screening, HIV testing and counselling, cancer screenings (such as Pap smears and mammograms), childhood hearing and vision screenings and various vaccinations. These benefits are available on all options and paid from risk, subject to eligibility criteria.

2. How often can I use my screening benefits?

Most screenings are covered once per benefit year, but some have specific age-based or frequency rules. For example, mammograms are available annually for women 40+, and faecal occult blood tests are available annually for members aged 50–75.

3. Are vaccinations covered by GEMS?

Yes. GEMS covers influenza, pneumococcal, HPV, COVID-19 and a wide list of additional vaccines. Some vaccines require pre-authorisation or a prescription from a healthcare provider. A separate annual limit of R950 per beneficiary applies to certain vaccines.

4. What HIV prevention benefits are available?

Members have access to PrEP, PEP and VTP/PMTCT benefits, depending on their risk and clinical need. These benefits require a prescription and pre-authorisation and are paid from risk.

5. Which healthcare providers can I visit for preventative screenings?

This guide lists approved providers for each service — including GPs, specialists, pharmacies, registered nurses, radiologists, optometrists, audiologists and pathologists.

Working towards a healthier you

Members must ensure they visit the correct provider type for the specific screening to be covered.

FAQs for Providers

1. Which preventative services are reimbursed from risk?

All listed preventative screenings and vaccinations in this guide are funded from the risk benefit when members meet the eligibility criteria. This includes screenings for cholesterol, glucose, HIV, cancer, childhood hearing/vision and more.

2. What tariff codes should providers use for preventative services?

Each screening and vaccination has specific tariff codes outlined in this guide. Providers must use the correct codes (e.g., 4027 for cholesterol finger prick, 0190–0193 for Pap smear consultations, 39175 for mammography) to ensure claims are processed correctly.

3. Are there age or frequency limits providers should be aware of?

Yes. Many services have strict age and frequency rules. For example, Pap smears for women aged 12–65 once per year, prostate screening for men 45–69 once per year and childhood hearing screenings once per developmental stage. Providers must verify eligibility before rendering services.


4. Do vaccinations require pre-authorisation or prescriptions?

Some vaccines require pre-authorisation (e.g., certain hepatitis vaccines) and many require a prescription if dispensed at a pharmacy. Providers should confirm requirements before administering or dispensing vaccines.

5. How should providers guide members regarding HIV prevention benefits?

Providers may prescribe and initiate PrEP, PEP and VTP/PMTCT services. These require pre-authorisation and must follow the clinical criteria outlined by GEMS. Providers can direct members to the GEMS HIV Department for additional support.
